Email addresses

The Trust is also moving to greater use of email in this digital era. While there will continue to be periodic letter mail-outs and the twice yearly printed Newsletter, we will be using email in some instances where we need to pass important information to you, either for Health & Safety reasons (such as regarding the coronavirus or fire safety) or in the management of your tenancy. For this we need to know your email address if you have not previously provided it and will use this solely in accordance with Data Protection requirements: there is a short note regarding this overpage and you have previously been issued with a copy of our Privacy Notice.

We also intend to issue a quarterly e-newsletter which will contain useful information about both the Trust as well as other things that we think you may be interested in, such as how to order replacement medals and about the long-awaited Veterans ID card. Data Protection regulations require that you have to opt-in to receive such information – and we have indicated that below. We will not use this for marketing purposes and we will never pass your personal data (such as contact information) to anyone outside the Trust without your permission except where it is necessary to do so in managing your tenancy (such as with a repairs contractor). In these instances we ensure that the contractor is first signed up to a Data Processing Agreement which safeguards your data.
