

The Constable of the Tower's Charity of the Year

Lord Dannatt chooses Haig Housing and the Coming Home campaign

We are delighted to announce that General the Lord Dannatt, former Chief of the General Staff and now Constable of the Tower of London, has chosen Haig Housing for his charity of the year 2015. In commemoration of this and our Patron, HM The Queen's milestone year (see page 2), we will be holding a wonderful event, 'For Queen and Country', in the Tower of London in September 16 this year.

We are grateful to Lord Dannatt, Patron of our Coming Home fundraising campaign, for his continued dedication, commitment and enthusiasm for our cause. Being chosen as Charity of the year follows also choosing us to be one of the charities to benefit from the sales of the WWI commemorative ceramic poppies in the moat of the Tower of London last year.





Veterans Accommodation Fund money being put to good use

Some of the £14.6m awarded to Haig Housing last year from the Veterans Accommodation Fund is already invested in the projects. 9 flats have been bought in Colchester and 11 in Aldershot. These properties form part of a 'Veterans Pathway' in conjunction with other Service charities specifically Stoll and Riverside.

Plans are also well underway for 15 new homes on the Haig estate in Edinburgh and for further housing in Morden. Morden is our largest estate with almost 20% of Haig's properties. The area is in high demand as it has good transport links to all parts of London and the South East and is, therefore convenient for employment education and recreation opportunities.

First House bought with Tower Poppy funding

With over £1m expected from the share of the funds raised by selling the 888,246 ceramic poppies at the Tower of London last year, plans are in place to use the funds to provide a number of 'Tower Poppy' Houses. The first house is being purchased in Taunton, Somerset and will suit the mobility needs of an ex-Royal Marine Sergeant who was badly injured in a Land Rover accident in Afghanistan in 2007. We are pleased to announce that Paul Cummins, who designed the Tower of London poppies, will design a commemorative plaque for these houses.

Trust News



Patron

On September 9, our Patron HRH Queen Elizabeth II will become the longest ever reigning monarch in British history passing the record set by her great-great-grandmother Queen Victoria. Buckingham Palace has calculated that Queen Victoria reigned for 63 years and 216 days; 23,226 days, 16 hours and 23 minutes (this includes 15 leap days and precise timings of her accession to the throne and her death).

Queen Elizabeth II will enter the history books taking into account 63 years plus 16 leap days and the timing of George VI's death.

To commemorate this event, Haig Housing is holding a Coming Home fundraising event at the Tower of London on 16 September.

Queen Victoria came to the throne on June 20 1837. She became the figurehead of a vast empire and her reign spanned the rest of the century amid great industrial, cultural and scientific changes to society. From 1861 until she died on January 22 1901, she wore black, mourning the early death of her consort Prince Albert.

At the age of 25, Princess Elizabeth became Queen Elizabeth II on the death of her father King George VI, who died in the early hours of February 6 1952. Like Victoria, she has acted as a figure of continuity as the country has modernised. She has served, with the Duke of Edinburgh at her side, through the 20th century, the Millennium and into the 21st century, witnessing new technological advances and a succession of British governments of different political persuasions.

The Queen has reached countless milestones and broken records during her decades on the throne:

- In December 2007, she became the longest living British monarch, overtaking Victoria who died when she was 81
- May 2011, she became the second-longest reigning monarch in British history, when she overtook George III.
- She holds the world record for most currencies featuring the same individual
- In 2012, the Diamond Jubilee river pageant set a new world record for the number of boats in a parade with more than 1,000 vessels taking part and 670 making the complete trip down the Thames to Tower Bridge.

The Queen is the second longest-serving current head of state in the world after King Bhumibol Adulyadej of Thailand, who has been on the throne since 1946.

At the Investiture in March at Windsor Castle, David spoke with Her Majesty and was delighted to find that, as the Trust's Patron, she keeps up with and was very interested in our recent developments with the Veterans Accommodation Fund and our involvement with the Tower Poppies last year.

WOULD YOU QUALIFY FOR A F RE EYE TEST AT HOME

If you find it difficult to get to an optician for physical or mental health reasons, you may qualify for a NHS eye test at home. In Scotland, all residents with physical or mental illness would qualify for this and in England and Wales you would qualify if you are any of the following:

- Aged 60 or over
- Registered blind or partially sighted
- Have been diagnosed with diabetes or glaucoma
- At risk of glaucoma
- Aged 40 or over with family member diagnosed with glaucoma
- Receiving benefits or hold a valid NHS tax credit exemption certificate
- On a low income and named on a valid HC2 or HC3 certificate
- Eligible for an NHS complex lens voucher

The Charles Wray In Memoriam Pension Fund

Small annual pensions can be paid from this fund to members or former members of the Armed Forces who are suffering from any physical nervous or mental incapacity or disablement either permanent or temporary which is attributable to or has been aggravated by their service.

Priority is given to people whose parents were resident at the time of the applicant's birth in the County of Yorkshire or the County Borough of Croydon or who were resident themselves in Yorkshire or Croydon at the commencement of or during the service in the course of which,

or as the result of which, the incapacity was acquired. (You do not have to be a Haig Housing tenant to qualify so, if you know of someone who might, please pass on this information).

Sir John Holmes Independent Medal review

Following this review, the Government has announced new medal eligibility:

Berlin Airlift: The General Service Medal 1918-62 with 'BERLIN AIRLIFT' clasp will be awarded to all aircrew, RAF and civilians, who took part in the Berlin Airlift from 25 June 1948 to 6 October 1949 inclusive.

Cyprus: 1955-59 for those who participated in suppression of terrorism in Cyprus and 1963-64 for those who served in Cyprus during this period.

South Atlantic Medal: Those qualifying for the medal now include those who served in the Falklands or their dependencies from 12 July to 21 October 1982 when the airfield at Mount Pleasant became operational.

The Poppy Factory's Get You Back to Work programme

For wounded, injured and sick ex-Forces personnel in England and Wales (and some in Northern Ireland) who, having been out of the Military for two years or more, are looking for employment or appropriate voluntary routes back into employment, the Poppy Factory offers a free of charge one-to-one tailored support through a volunteer network of professional mentors. They who assist with areas of job research and application support, and provide access to a network of industry contacts and roles with organisations who value the skills and experience of ex-Forces personnel. Clients injury's or conditions do not have to be attributable to service in order to receive support.

Armed Forces Covenant Update

The Armed Forces Covenant is an agreement between the Government, the Nation and the Armed Forces to commit to supporting the entire Armed Forces Community to ensure that Service personnel and their families are not disadvantaged by the sacrifices they made to keep the nation safe.

Last year:

- a further £40m was made available from the LIBOR fines to Covenant projects bringing the total to £140m
- All Local Authorities have signed up to the Covenant ensuring the needs of Armed Forces families are taken into account on such things as housing and schools
- Over 370 companies have also signed up making a range of commitments from jobs to making it easier for staff to join the reservists

This year:

- a new Service Complaints Ombudsman will be introduced
- The Armed Forces Pension Scheme will be opened up to Reservists
- A new £10m annual fund will be launched to continue delivering Armed Forces Covenant commitments

Housing Services

Universal Credit rolling out throughout the UK. Will it affect you?

If you are currently on Housing Benefit and/or other benefits, you will be put onto Universal Credit as the programme of welfare reform rolls out.

If you have any worries about what is happening to your financial support, please don't leave it until you are in trouble; speak to your Income Officer at Haig by telephoning 020 8685 5777 and selecting 'Option 4' or speak with your Housing Manager.

Whilst we have tried to minimise the impact of these reforms, we are aware that, especially to begin with, there may be problems. For example, as the money is paid a month in arrears we expect to see more people worried that they are behind with their rent payments. Alternatively, people may feel they cannot afford the extra money needed.

Research by the National Housing Federation has shown that 92% of tenants say they would prefer their housing benefit to be paid directly to their landlord. If you are one of this percentage and would like a bit more guidance and help, please contact us.

It is important to remember to spend the money allocated to you on rent and other necessary things before spending the money elsewhere.

Reporting crime to the police

If you witness or are a victim of a crime, or you have information relating to one, you should report it to the police as soon as possible and then notify Haig when convenient if appropriate.



Reporting to the Police:

- Call 999 if you are reporting a crime that is in progress or someone is in immediate danger. Calls from landlines and mobiles are free
- For local community policing issues contact your local Policing team it is a good idea to find this number and keep it handy in advance of any incident
- Call 101 to report crimes that are not an emergency, to give information or make an enquiry. Calls
 from both landlines and mobile networks cost 15 pence per call, no matter what time of day you
 call, or how long you are on the phone
- Call Crimestoppers on 0800 555 111, or email https://crimestoppers-uk.org/ to report a crime or give information completely anonymously
- Call 999 or the police anti-terrorist hotline on 0800 739 321 to report an immediate terrorist threat

Rent Payments

The Income Officers are always looking at ways to help tenants with rent payments and are at the end of a phone if there are any problems with paying rent. It is much better to talk to someone than let yourself get behind. Here is some helpful information.

DIRECT DEBITS: Haig Housing is looking at the possibility of setting up Direct Debits as another method of rent payment. If you are interested in this way of paying please contact the Income Team on 020 8685 5777 option 4 to register your interest.

RENT INCREASE NOTICES: If you receive Local Housing Allowance/ Housing Benefit it is your responsibility to take your rent increase notice down to your local benefits office.



STANDING ORDERS: When you receive your rent increase notice you need to amend your standing order, this should be increased on the payment prior to the rent increase. Standing order is between you and your bank and is not something that any Haig employee can change on your behalf.

RENT PAYMENTS: When making rent payments to Haig Housing please use your tenancy number as the reference for your payment. Failing to quote the correct reference can lead to a delay in your payments being credited to your rent account.

Coming Home: A Hundred Years of **Housing Heroes**



Coinciding with many Military centenary commemorations associated with WWI, this new book Coming Home: A Hundred Years of Housing Heroes, tells the story of this charitable housing association set up to help injured Servicemen coming home from War, facing a very different life than they might have expected.

Written by the Trust's Fundraising & PR Director, Anna MacLeod, the book explores the history of Haig Housing starting in 1928 on the death of the illustrious and later notorious, First World War General, Field Marshal Earl Haig. The then Prince of Wales and other members of Britain's post war society, felt that the provision of good quality

housing would be a fitting memorial to the Field Marshal and his tireless work, after the war, to improve the living and working conditions for the returning disabled Soldier and his family.

By the mid 1930s, a network of houses had been built specifically to accommodate disabilities. The properties were spread throughout the UK and the largest estate was in Morden, South West London, which was opened by the Prince of Wales to great excitement on 29th May 1931.

The Trust has grown through new build and absorption of Regimental Homes and other smaller Trusts such as The Housing Association for Officers' Families, which was formally established, in 1916, by society hostess Mrs Willie James. She helped house Officers' widows from 1914, giving the Trust its 100 year history.

The book is more than just the history of the Trust. It carries spotlights on Royal Patronage, benefactors, tenants, supporters and contributors to the Trust throughout its history. Packed with anecdotes, tales of derring-do, stories and snippets of social and historical interest. the coffee-table style book is illustrated with hundreds of photographs drawn from Haig's extensive and fascinating archives. The book is relevant to all tenants and some current tenants are featured in the book.

Lord Dannatt, Patron of the Coming Home fundraising campaign, says of the book, "Somewhere to call home is the building block for life, and Haig Housing has been providing this for returning Service men and women for a hundred years. This remarkable book tells a remarkable tale about the housing help given to remarkable people."

A Volunteer Estate Monitor (VEM) said, "This morning we received our long awaited Coming Home book, and what an interesting book it is turning out to be. It will be slowly read as the amount of information gathered is astonishing. Very little housework will be done in this house today!"

Gloria Hunniford, a Coming Home supporter, also read the book and said it is, "utterly superb, fascinating and clearly presented."

War Horse Memorial

In the summer of 2016, there are plans for Ascot to be home to the first ever memorial dedicated to commemorating the one million Allied horses that were lost in the First World War.

A larger-than-life bronze sculpture of a typical animal used to transport munitions and men during the four-year conflict will remember their contribution, and signify the last time the horse would be used on a mass scale in modern warfare.

Acclaimed sculptor Susan Leyland has been commissioned to carry out this extraordinary tribute to the hundreds of thousand

of horses, donkeys and mules which lost their lives and will be a fitting acknowledgement to the unspoken, uncomplaining and inspirational nobility of the horse.

You may have seen this Give as you Live®

for suppliers on the internet. If this sign is next to the name of a supplier, it means that they give a percentage of anything you purchase through them to your chosen charity.

It is a really good way for us all to raise money for charity - it doesn't cost anything and it's free to sign up (Give as you Live make their money from the suppliers who join up to the scheme and are therefore more likely to get chosen by buyers).

Heyland & Whittle have also produced a wonderful limited edition box set commemorating the battle of Waterloo, 18th June 1815. The box has two soaps; hemp and Walnut and Rose 10% of the proceeds are being donated to Coming Home. A Heyland ancestor, Major Arthur Heyland lost his life at Waterloo commanding the 40th Regiment of Foot. On the eve of the battle, he penned these wonderful words to his wife, clearly the love of his life.

"My Mary, let the recollection console you that the happiest days of my life have been from your love and affection, and that I die loving only you and with a fervent hope

that our souls may be reunited hereafter and part no more. What dear children, my Mary I leave you. My Marianna, gentlest girl may God bless you. My Anne, my John, may Heaven protect you. My children may you all be happy and may the reflection that your father never in his life swerved from the truth and always acted from the dictates of his conscience. preserve you virtuous and happy, for without virtue there can be no happiness. My darling Mary I must tell you again how tranquilly I shall die, should it be my fate to fall, we cannot, my own love, die together, one or other must witness the loss of what we love most. Let my children console you my love. My Mary."

Property Services

You said... we did... Improving Your Repairs and Maintenance Experience

Haig values the feedback it receives from tenants and as a result of your comments and suggestions has been trying to gradually improve the repair and maintenance experience which remains an area of keen interest judging by our email box and post bag.

Changes started just over a year ago with a shift to the use of gas contractors who had the capacity to deal with the geographic spread of our properties including an evening and weekend emergency service but also to provide some consistency in the service provided.

Initial feedback seems to suggest that this has been a good decision with a more responsive and consistent service but the work continues and in addition to refining the gas contracts, we have now turned our attention to the general repair service.

A number of small pilot schemes have been started around the country with national contractors. We intend identifying the best repair model for Haig and to incorporate improvements that result from the schemes into new contracts some time next year.

We are still using local contractors where they have proven to be popular and provide a good service and the tenants of those properties included in the pilots and the Volunteer Estate Monitors have been written to separately with specific information and new feedback forms.

Exciting news for Haig Housing

Empty properties to become new homes for armed forces veterans in landmark scheme









The BBC's DIY SOS, The Big Build programme is working with the charity Walking With The Wounded and Haig Housing on a significant empty homes project to establish a veteran's community with access to support, education and training in Manchester. Manchester City Council and Adactus Housing have agreed to give 25 empty homes in Newton Heath to Haig to create an armed forces veterans' housing community. With street landscaping to provide disabled access and improve the environment, along with a face-lift of all the properties on the streets. DIY SOS plans to refurbish eight of the properties to create four adapted residential homes for veterans and their families and a veteran walk-in support and advice centre to be run by Walking With The Wounded. The remaining 17 empty properties will be refurbished by Haig Housing. The Big Build refurbishment will work using donated materials, equipment and on-site labour by veterans and their families. Skills will be donated by contractors and local businesses and organisations such as the local Army Reserve (75th Engineer Regiment) which has already offered workforce and equipment.

All parties are very positive about this substantial project:

Cllr Jeff Smith, Manchester City Council's executive member for housing and regeneration,

said: "The city council has committed to an armed forces covenant to work with and support our armed forces returning to civilian life. This project is a timely and practical demonstration of how we can provide this support and at the same time benefit

the local residents and the city by bringing empty homes back in to use. Through this programme we hope to offer not only suitable housing but ongoing advice and support. This includes training and education, in partnership with local schools and colleges, to help veterans find employment and support themselves in the future."

Edward Parker, CEO and Co-Founder of Walking With The Wounded, adds: "this is a remarkable

opportunity for our veterans.... to gain their independence outside the military; two of the key factors for this to succeed is a home and a job. This project will provide both. It also gives the charity the chance to be embedded in the community to extend our reach further into the northwest where there are many veterans and their families who would benefit from our support."

Chief Executive of Haig Housing, James

Richardson, said: "We are delighted to be involved with this project. As the leading provider of housing to ex-Service community and with our experience in providing specially designed and adapted accommodation for both Service and ex-Service personnel who have been severely wounded and traumatically disabled, we are well placed to deliver homes which meet the needs of our applicants and tenants."

Paul Lees, Chief Executive of Adactus Housing

Group, said: "We are excited to be working in partnership on a project that will make a significant improvement to people's lives, aid regeneration of a neighbourhood and build a sustainable community."

Chris Young, who spotted this interloper, says, 'the Harris Hawk is normally resident in South America, in particular Mexico but is popular in the UK with Falconers. This bird was an "escapee" and we worked hard to capture it to re-unite it with its owner. This wasn't easy as it had

with its owner. This wasn't easy as it had quickly adapted to the local conditions and was managing to feed itself well. A well-fed bird will, after such a length of time, not easily be lured back to the fist. Sadly this was true and the hawk has managed

to go through the winter and is still at large. The pigeon on which the Harris is dining in the picture (on the porch of one of our

houses) was a break from the local chickens he snatched regularly.

Chris, the estate's VEM, is interested in wildlife and says, "We see a lot on our estate even though we are on the edge of an industrial town! The bird tally is well over 60 species and our best sighting was a Scarlet Rosefinch two years ago. Ours was one of only two verified sightings that year of a bird normally resident in Scandinavia and probably blown off course."

'Mighty oaks from little acorns grow'

Commemorating the Great War in Norwich

At the annual Armistice Day service at the War Memorial Cottages and Bungalows in Norwich last year, two oak trees were planted in commemoration of the centenary of the outbreak of the Great War.

About 150 people overall attended and witnessed the trees being planted immediately after the 2 minutes silence and wreath laying at the War Memorial. They were dedicated by the Royal Anglian Regiment Regimental Chaplain, The Revered Father Ken Reeve, to the memory of all those who served in The Great War.

Both trees were provided by the contract gardeners, the CGM Group, with one being planted on behalf of Haig Housing by current and former residents and the other by the Crosskill's Artillery Battery Army Cadet Force who were formed by a Royal Norfolk Regiment officer in 1911.

shortly after her family moved in and still lives locally. It is interesting to note that the current resident, who moved in last year, is only the 3rd resident in that property in its whole 93 years.

In January this year, a resident at Macdonnell Gardens, had a long overdue recognition of his bravery during WWII. Lieutenant Anthony Eldridge, Tony to his friends, was a member of an elite Submariner group of very brave men who were known as 'human torpedoes' or charioteers. At 19, he signed up for Special and Hazardous Service whilst serving with the Royal Navy and, following secret training, secret even to him and the others involved, in 1944 he found himself in Ceylon, piloting a torpedo shaped chariot on a top secret and highly dangerous mission to blow up a Japanese controlled Italian liner. He wasn't expected to survive the mission to place a 1,000lb warhead onto the hull of the liner.

Tony's dedication that night was recognised with the award of the DSC (Distinguished Service Cross) for 'gallantry, skill and devotion to duty shown while serving in His Majesty's Submarine Trenchant on successful patrols in Far East waters' and his co-pilot, Butch Woollcott received the DSM (Distinguished Service Medal). In recognition of his tremendous bravery, just over 70 years later, Flag Officer Submarines invited him to

visit the Headquarters in Northwood and stay for lunch at his official residence. Tony had a marvellous time and is pictured here with Haig's Chief Executive, James Richardson and Admiral Matt Parr, Commander operations and head of the Submarine Service in front of the Jolly Roger the emblem of the Royal Navy Submarine Service. In World War II it became common practice for the submarines of the Royal Navy to fly the Jolly Roger on completion of a successful combat mission where some action had taken place. This was seen as an indicator of bravado and stealth rather than of lawlessness the Admiral of the Fleet, Admiral Sir Arthur Wilson, pronounced about submarine warfare in 1901. He said it was "Underhand, unfair and damned un-English" and that the Royal Navy should "treat all submarines as pirates in wartime".
